TERMS & CONDITIONS

Must be signed and returned with enrollment form.

Effective Dates of the Community Contributions rewards Program: The Community Contribution Program ("Program") will commence and become effective September 1, 2008, or the date the application is processed, which ever is later and will terminate August 31, 2009 (the 'Term') and may be extended at the discretion of Ralphs Grocery Company ("RGC").

Program Terms and Conditions: Subject to the terms and conditions hereof, RGC will contribute to eligible Organizations (as defined below) an amount that is equal to a portion of the total Eligible Purchases (as defined below) made by the Eligible Participants (as defined below).

Eligible Organizations: Eligible Organizations are qualified 501(c) 3 Non-Profit Organizations located in California and who have submitted an application form, have agreed to all Terms & Conditions and received confirmation from RGC.

Eligible Participants: Eligible Participants shall be Ralphs rewards Card holders who are 18 years of age or older and who are legal residents of the city or state in which the Eligible Organization is located and who have either identified themselves as a participant of an Eligible Organization or who have been identified as a participant by an Eligible Organization. These are only members, family and friends of Eligible Organizations.

Eligible Purchases: Eligible Purchases shall consist of those retail purchases made at any Ralphs by an Eligible Participant who presents a Ralphs rewards Card at the time of purchase. If the card is not presented during a transaction, your organization's account will not be credited. Purchases of alcohol, tobacco, pharmacy, postage stamps, gift cards, gift certificates, lottery and promotional tickets, fluid milk and milk products, fuel CRV and Sales Tax are excluded from eligible purchases.

Other Program Conditions:

- a) Eligible Organizations and Eligible Participants shall be solely responsible for the accuracy of all names submitted as Eligible Participants. Eligible Organizations shall agree to indemnify and hold RGC harmless in connection with their identification or improper identification of any person.
b) Solicitation to the General Population is prohibited and is grounds for exclusion from the Community Contribution Program. Only member, family and friends are eligible to participate in your organization.
c) Eligible Organizations are prohibited from soliciting in front of or inside any Ralphs Grocery Store or public event.
d) This is a stand-alone rebate program and any attempt by an organization to combine this program with any other Kroger affiliated rebate or discount program could result in exclusion from the Community Contributions Program.
e) All proceeds derived from the Community Contribution Program must be used for charitable purposes within the communities Ralphs serve and cannot be used for political, legal or administrative purposes. RGC has the discretion and right to terminate any Organization from the Program at any time if it is determined that any of the proceeds are used for political, legal or administrative purposes
f) No person is required to make payment of any kind in order to be issued a Ralphs rewards Card.
g) More than one Ralphs rewards Card when linked together is considered a household. If a participant is issued a replacement rewards Card (i.e.: 1-2-3 rewards Card) it is the responsibility of the participant to confirm that the cards are linked properly and/or re-register their new rewards Card in the Community Contribution program.
h) If customer is using an alternate ID (phone number) at the register, it is the responsibility of the card holder to confirm that the registered card is linked with their alternate ID (phone number).

Payment Conditions:

- a) Total Eligible purchases made by the Eligible Organization's Eligible Participants will be calculated at the end of each three-month period during the Term. Purchase amounts by Eligible Participants during any one three-month period shall not count towards amounts purchased in any subsequent three-month period.
b) Rebates will be paid and mailed only to the Organization identified on the Program Enrollment Application via check or in some cases will be personally delivered to your organization by your neighborhood Ralphs Store Director within one month of the close of each quarter. Rebates are paid quarterly in December, March, June, September, based on the following quarters: 1) September through November 2) December through February 3) March through May 4) June through August.
c) Minimum quarterly rebate payout is \$25 per Organization. In the event that an organization earns less than \$25 in a quarter, Ralphs will hold the amount until the next quarter that the rebate exceeds \$25 or the end of the program Term, whichever come first.
d) The amount of the rebate to be paid to an Eligible Organization at the end of each three-month period shall be determined in accordance with the following scale:
Up to \$200 per month of eligible purchases 1%
Between \$200.01 and \$350 per month of eligible purchases 2% of amount over \$200
Between \$350.01 and \$500 per month of eligible purchases 3% of amount over \$350
Over \$500 per month of eligible purchases 4% of amount over \$500
e) Ralphs rewards limits their quarterly contributions to a maximum of \$750,000 to be distributed among all participating eligible organizations, and \$150 per individual rewards Card. In the event that total earned contributions exceed the maximum contribution limit, Ralphs will prorate and reduce the contributions based on the total contributions earned by all participating organizations and their members.

RGC reserves the right to evaluate the Program during the Term and to unilaterally modify the Program at any time and without any advanced notice to the Organization. When possible, the Organization will be given ten (10) days advance written notice of any changes to the Program. The Organization may elect to terminate its participation in the Program at any time. RGC may elect to terminate the Program at any time. The Program is void where prohibited or restricted by law.
